Amendments on "Regulations on Veterinary Controls on Preliminary Notification and Enterance of Animals and Animal products to Turkey" was published in the Official Gazette on April 30th, 2020.

Depend on this Regulation, "Communiqué on Approval of Control Certificate in Animal Product Import and Documents to be Submitted at the Stage of Import" was also published.

According to the amendments of the Regulations and Communiqué;

During the entry of products subject to the veterinary checks until July 30th, 2020, in case of sending original veterinary health certificates of the official authorities of the exporting countries have been scanned in color in an electronic environment, to the e-mail address of hayvansalurunithalat@tarimorman.gov.tr and the control point directorate or the authorized provincial directorate, it is possible to carry out the procedures for veterinary controls if it is guaranteed that the originals will be presented by the importer within three months from the date of import.
