4	The members who are eligible to vote and have any objection to the entries in the list of voters shall send their objections in writing to Secretary General	Thursday July 28, 2022
5	Secretary General to intimate action on the objections or changes sent by members who are eligible to vote	Tuesday August 2, 2022
6	Any person aggrieved by the decision of Secretary General may make representation to the Election Commission	Friday August 5, 2022
7	Election Commission to decide representation of the aggrieved person	Thursday August 11, 2022
8	In case the Election Commission fails to decide within the stipulated period, aggrieved person may appeal to the Regulator under written intimation to Secretary General of his intension of filing appeal	Monday August 15, 2022
9	The Regulator to decide appeal and his decision in this regard shall be final	Thursday August 25, 2022
10	Display of final list of eligible voters on the notice board & website of ICCI	Saturday August 27, 2022
11	Any person who is eligible to contest the election for vacant post of the Executive Committee to obtain nomination papers from Secretary General (payment of non-refundable fee by a member at the time of obtaining nomination paper Rs.25,000/-) (9:00 a.m. to 5:00 p.m.)	Monday August 29, 2022
12	Submission of nomination papers to Secretary General duly proposed and seconded by duly registered voters and signed by the candidate (9:00 a.m. to 5:00 p.m.)	Wednesday August 31, 2022
13	Scrutiny of nomination papers by the Election Commission, display of list of candidates and a copy of final list of voters to be provided to each contesting candidate whose nomination papers are in order	Thursday September 1, 2022
14	The objection, if any, to the nomination of the candidates can be filed to the Election Commission	Friday September 2, 2022
15	Election Commission to decide objections	Monday September 5, 2022
16	Any candidate, aggrieved by the decision of the Election Commission, taken under preceding clause or in case Election Commission fails to decide within the stipulated time, may file an appeal to the Regulator	Wednesday September 7, 2022
17	The Regulator to decide the appeal and his decision in this regard shall be final	Wednesday September 14, 2022
