Meeting started with the recitation from the Holy Quran by Mr.Khalid Mehmood.

Following was the agenda of the meeting:-

Personal hearing of Syed Nadeem Mansur before the Executive Committee in Compliance of the DGTO Order in Original No.12/2023 dated 24-05-2023

Mr.Ahsan Zafar Bakhtawari, President welcomed everyone in the meeting and asked Syed Nadeem Mansur to present his grievances before the Executive Members as per DGTO Order in Original No.12/2023 dated 24-05-2023.

In the beginning of the hearing, Syed Nadeem Mansur raised the question about quorum and he was informed that quorum of the meeting is complete. He asked permission for video and audio recording of the hearing, which was not allowed by the Executive Committee.

Syed Nadeem Mansur thanked the Executive Committee for providing him the opportunity of hearing and to present his grievances regarding the Italy delegation. He said that he is part of the "Founder Group" but contested annual elections as an independent candidate. He requested to consider him as a friend and not an enemy, and said that criticism is for the benefit of the Chamber, however, he has to register his concerns as an opposition leader.

Syed Nadeem Mansur said that he has submitted a letter to ICCI to get the details of Italy delegation raising the questions that, what was the criteria of selection of delegation members, how invitation was received, the list of delegation members and non-members who were the part of the delegation, how the trip to Italy was organized, what was the total charges per head, details of the delegates meetings and what kind of benefit ICCI got from the Italy delegation. He said that if he was ignored then it would not be suitable for the Chamber.

Mr. Nasir Mansur Qureshi replying said that ICCI has provided him the opportunity of hearing in a professional manner. He said that Executive Committee has noted the concerns raised by him, whereas, ICCI Secretariat should provide the relevant permissible information as and when directed by Executive Committee.

Mr. Ahsan Zaffar Bakhtawari, President informed that the issue of the Italy delegation has already been discussed in the Executive Committee and reply was submitted in the DGTO office. He read the DGTO Order point by point and informed Syed Nadeem Mansur that SOP's of the delegation have been submitted to the DGTO office. He said that a 4-member Enquiry Committee from Executive Members shall be constituted to inquire into the matter as to why the Secretary General failed to upload the information regarding delegation to Italy on the website of the Chamber in particular and did not disseminate the information amongst the members in a transparent way in general. President said that Enquiry Committee shall conduct enquiry in two weeks' time and minutes of this meeting shall be uploaded on the ICCI website after approval of the Executive Committee.

Meeting then ended with a vote of thanks.
