The House then took up the following agenda of the meeting: -

1. To approve minutes of the 11th Meeting of the Executive Committee (2022-23) held on August 31, 2023.

Mr. Faad Waheed, Senior Vice President proposed to re-constitute the HR-committee. President said that committees shall re-constituted in the next month.

2. To approve accounts of the Chamber for the month of August 2023.

To approve Audited Accounts for the year ended on June 30, 2023.

The draft audited statement of accounts of Islamabad Chamber of Commerce & Industry ending in June 2023 along with a letter No.CHE/ICCI-01/23 dated September 25, 2023 addressed by the Auditor to the Board of Directors was presented to the House.

The House said that the audited accounts should have been prepared well in time. It was informed that there was a delay because of some clarifications by the auditor. The Assistant Secretary Finance gave its details to the House. The House approved the draft audited accounts and considered the recommendations of the auditor mentioned in the said letter.

The House resolved to approve points mentioned at point (b) in the said letter. The House formed a Committee headed by Ms.Munizeh Majid for the consideration of the matters mentioned in the said letter and taking appropriate actions on them in due course of time including property and equipment, standard operating procedures/manuals, long terms advances, other income from events, anti-money laundering and terrorist financing policies and controls, anti-fraud programs and controls, risk register, unique document identification number (UDIN), contingencies and commitments, related party transactions, compliance with statutory laws and regulations, fraud, Independence, subsequent events.

The House then approved the audited accounts for the year ended on June 30, 2023.

Mr.Ahsan Zafar Bakhtawari, President proposed to appoint M/s Alam & Aulakh, Chartered Accountants as Auditor for the next year, which the House after discussion approved to appoint them as ICCI auditors for the year 2023-2024.

6. To consider any other point with the permission of the Chair.

The following points were considered with the permission of the Chair:-

Mr.Akhtar Hussain said that last year one additional seat of the Vice President was approved in the Executive Committee meeting and Annual General Meeting and stressed for its implementation. He also congratulated the House for setting up the office of the Mediation Council at ICCI, which House also appreciated. He proposed to fix the quorum of the Annual General meeting to 300 members, which the House seconded and approved.

Mr.Muhammad Ali gave the details of the placement of order for the installation of 250 KVA generator in the EDC building.

Raja Muhammad Imtiaz said that annual increase in the salaries has been given to the employees, but he said that salaries of a few employees needs to be reviewed and adjusted.

Mr.Muhammad Rizwan Chheena proposed that ICCI should file a writ petition against 7E in the High Court. After discussion that it was decided by the House to wait for it.

Mr.Faseeh Ullah Khan thanked Sh.Muhammad Ijaz for hosting a fabulous dinner in honour of the President and Executive Members. He appreciated the role of Mr.Ahsan Zafar Bakhtawari for effectively presenting the point of view of the members in the CDA Board, however, he said that development work in the markets is not up to the mark, especially in the G-series. He highly appreciated that Mr.Ahsan Zafar Bakhtawari, President has announced one crore from his personal pocket for the development work in the markets, whereas, one crore rupees shall be collected from the sponsors. He said that Ch.Abdul Majeed, CEO Faisal Town has also announced one crore rupees for development work, and he proposed that ICCI should also contribute one crore rupees for market development. Mr.Ashfaq Hussain Chatha

said that it is a big amount and this initiative will create a number of issues and proposed to generate this amount from some other sources. After discussion the House proposed to present this matter in the Annual General Meeting for consideration.

Mr.Majid Shabbir, Secretary General said that his health is not well and it has not been possible for him to continue his job, and he tendered his resignation before the House. He thanked the Office Bearers, Executive Members, all senior members and his fellow colleagues for their great cooperation during his long association with the Chamber. The House stressed to continue job, but he said that his health does not allow him to continue.

Mr.Faseeh Ullah Khan said that 4th floor of EDC building is vacant and proposed to set up a Medical Clinic at the half portion of 4th floor. He gave the details of the proposed plan to the House. After discussion, the House approved to set up a Medical Clinic as proposed.

Since no other points were to be discussed, therefore, the meeting ended with a vote of thanks to the Chair.
