The meeting commenced with Mr.Muhamamd Rizwan Chheena reciting the Holy Quran.

At the onset, the House offered Fateha for the health of Mr. Humayun Kabir, an Executive Member. Vice President Engr. Azhar-ul-Islam Zafar informed that he has visited the hospital to inquire about Mr. Kabir's health, and he is now recovering and will be discharged soon.

Introduction of New Secretary General and Additional Secretary:

President Ahsan Zafar Bakhtawari, who chaired the meeting, introduced the new Secretary General, Mr. Ghulam Murtaza Siddique, and the Additional Secretary, Mr. Muhammad Zahid. The House gave unanimous approval to his appointment and warm!y welcomed them. The newly appointed Secretary General also showed his gratitude and feelings of being honored for serving the ICCI.

The House then took up the following agenda of the meeting:

To approve minutes of the 20th Meeting of the Executive Committee (2022-24) held on May 30, 2024.

Mr.Ahsan Zafar Bakhtawari, President ICCI in response to a query by Mr.Faad Waheed, SVP mentioned that the file custody from Rao Faisal-ur-Rehman regarding the plot taken over by ICCI against the sale of a stall in the ICCI Expo would be managed accordingly.

The House unanimously approved the minutes of the 20th meeting of Executive Committee.

2. To approve accounts of the Chamber for May 2024.

Proposal for Billboard Installation:

The House unanimously approved a proposal by AC (Rural) Islamabad for installing a billboard with a phrase such as 'I love Islamabad' or 'The Beautiful Islamabad' along with the Chamber's logo at T-Chowk (Entry point of Islamabad). The entire expense will be borne by the ICCI.

Printing of Booklets/Magazines:

On the proposal by Dr. Mohammad Usman, the House agreed that ICCI will print booklets/magazines detailing the BOC Dubai and APCPC-2024 for record-keeping and future use.

Official Car Evaluation and Purchase:

The House authorized President Ahsan Zafar Bakhtawari to evaluate the price of the official car with a 30% discount as per the highest bid to be sold to the Ex-Secretary General. The House also approved the purchase of a brand-new car for the new Secretary General.

Change of Signatories:

The House unanimously approved that from July 1, 2024, the signatory of all accounts/letters will be changed.

PLS Account Opening:

The House unanimously approved the opening of a PLS account for employees' gratuity in an Islamic Bank.

Tourism Summit in Skardu:

President Ahsan Zafar Bakhtawari informed that the Tourism Summit in Skardu will be organized in the second week of August 2024.

Upgradation of Munawar Mughal Hall:

The upgrade of Munawar Mughal Hall was deferred until September 2024.

Board Unanimous Resolution:

Whereas, pursuant to the provisions of the Trade Organizations Act 2013, the Islamabad Chamber of Commerce and Industry (hereinafter referred to as "the Company") has the authority to delegate signing authority for financial matters, whereas Mr. Ghulam Murtaza Siddique has been duly nominated and recommended by the Executive Committee of the Board of Directors to be authorized to sign all cheques and bank-related documents on behalf of the Company.

Whereas it is in the best interest of the Company to authorize Mr. Ghulam Murtaza Siddique to undertake these responsibilities to ensure efficient financial operations, therefore, be it resolved unanimously that:

"Mr.Ghulam Murtaza Siddique is hereby authorized to sign all cheques drawn on the ICCI's bank account(s), including but not limited to payroll, operational expenses, and other financial transactions.

Mr. Ghulam Murtaza Siddique is further authorized to sign all bank-related documents, including account opening forms, loan agreements, investment transactions, and any other financial instruments necessary for the ICCI's operations.

The President of the ICCI shall also have the authority to sign all such cheques and bank-related documents jointly with Mr. Ghulam Murtaza Siddique, as required by the Trade Organizations Act 2013 and other applicable laws."

This resolution shall remain in force until such time as the Managing Committee may amend or revoke it. "Resolved further that the officers of the ICCI are authorized and directed to execute and deliver such documents and take such further actions as may be necessary to effectuate the foregoing resolution." (Secretary General) (Additional Secretary General)

3. To approve the new Membership Applications:

President Ahsan Zafar Bakhtawari informed the House that Mr. Abdur Rehman Siddiqui has been nominated as the Convener head of the Membership Scrutiny Sub-Committee. Other Points Discussed:

Mediation Council Composition:

It was unanimously decided that the sitting President ICCI would be the Chairman of the Mediation Council. Fifty percent of the current members will continue in the next term, while the other fifty percent will be newly nominated, equally from CM and AM.

Opposition to Tax Imposition:

On the proposal of VP Engr. Azhar ul Islam Zafar, Mr.Axhtar Hussain, and Mr. Ashfaq Hussain Chattah, the House decided to continue raising its voice against the high imposition of taxes. SVP Faad Waheed suggested including industry representatives in the discussions.

Budget Action Committee Formation:

The House approved the proposal by Mr.Jamshaid Akhtar Shaikh, Chief Coordinator Tajir Dost Scheme Islamabad, to form an action committee to encourage traders to register with FBR. The committee will include President Ahsan Zafar Bakhtawari, Sardar Tahir, President IEAA, and Mr.Ajmal Baloch, President All Pakistan Anjuman-e-Tajraan. Additionally, a Budget Action Committee comprising Mr. Ashfaq Hussain Chattah, Dr. Mohammad Usman, Mr.Akhtar Hussain, and Mohammad Rizwan Chheena was formed.

Bilingual Meeting Agendas:

On the proposal of Mr.Muhammad Rizwan Chheena, the House unanimously approved that future meeting agendas will be issued in both Urdu and English.

Commendations:

Mr. Ameer Hamza commended the successful occurrence of the All Pakistan Chambers Presidents Conference, highlighting its significance for future ICCI office-bearers. He raised a query about the continuous absence of some Executive Committee members. The President Ahsan Zafar Bakhtawari informed the House that Mr. Nasir Qureshi had tendered his resignation on 7th June 2023. Query was also raised that in records the word "leave" is appearing which should be rectified. The President replied
