**3. Confirmation of Previous Minutes**

The minutes of the 20th Meeting of the Executive Committee (2024-26), held on Tuesday, March 31, 2026, were presented before the House and unanimously confirmed.

#### 4. Approval of Accounts

Approval of accounts for March 2026 was deferred to the next meeting, as the accounts had not yet been approved by the ICCI Standing Committee due to the preoccupation of Mr. Zubair Ahmed Malik, Chairman, with preparations for the inauguration of the SAARC Chamber of Commerce office in Islamabad.

## 6. Membership Renewal Report

On the direction of the President, the Secretary General informed the House that approximately 6,600 members had renewed their memberships. The announcement was welcomed with applause.

The President appreciated the efforts of Executive Committee Members, particularly Mr. Naveed Satti, Mr. Zulqurnain Abbasi, Mr. Imran Minhas, Mr. Ishaq Sial, and Mr. Abdur Rehman Siddiqui, for their active role in the renewal campaign. He noted that this figure was highly encouraging compared to the previous year, when renewals remained below 6,000. The President stated that this achievement reflected collective effort and the confidence of the business community in the Chamber's leadership.



He also requested participation of EC members in the Prime Minister House function scheduled for April 27, 2026.

**g) Staff Medical Insurance**

The matter of staff medical insurance was discussed in detail.

The President noted an estimated annual cost of Rs. 4.4 million and called for consensus due to financial implications.

Members expressed mixed views. Some supported the proposal as a welfare measure, while others suggested alternative support mechanisms.

After deliberation, the matter was deferred for further consideration in the next meeting.

**h) Inscription of Chamber's Name**

The proposal for installation of ICCI signage at the Srinagar Highway side parking area was presented. The House appreciated the proposal. The President stated that he would arrange sponsorship to beautify the ICCI frontage at Srinagar Highway.

**i) Gratitude to the Chair**

The House appreciated the President's efforts in facilitating the entry of wheat-carrying vehicles and other essential goods into Islamabad during the lockdown period.

**j) FM Radio License**

The President informed the House that the delay was due to the incomplete constitution of the PEMRA Board. He stated that efforts were underway for approval and directed the Secretary General to pursue the matter.

**k) Delegation Visits**

Plans for a China delegation were finalized. A proposed visit to Bishkek was under review, and discussions were ongoing regarding a Türkiye delegation, including a possible award ceremony under the supervision of Mr. Amir Waheed.

**l) President's Address**

The President briefed the House on challenges faced by the business community, particularly early market closures and related administrative issues.

He highlighted efforts made through ICCI for relief measures, coordination with authorities, and engagement with the Prime Minister and relevant ministries.



## **7. Any Other Point with the Permission of the Chair.**

### **a) Appreciation of Executive Committee Members**

The House approved the proposal to present shields to the top three Executive Committee Members in recognition of outstanding performance in membership renewal.

Mr. Mohsin Khalid Malik proposed formal recognition of leading performers. Mr. Zulqurnain Abbasi and Mr. Faisal Muzammal appreciated the President's active involvement, use of social media, and efforts in highlighting business community issues.

### **b) Appreciation for Hosting SAARC Chamber President**

The House appreciated the successful hosting of the President of the SAARC Chamber of Commerce and Industry in Islamabad. The House also congratulated Mr. Atif Iqbal on his election as Senior Vice Chairman. Mr. Imran Minhas noted that the event enhanced ICCI's regional stature.

### **c) Display of Pictures in Munawar Mughal Hall**

Upon a query, the President stated he was not aware of differences among Council Members regarding the display of photographs of FPCCI Presidents at ICCI. He added that had he been informed earlier, he would have advised seeking clearance from the Chairman.

He emphasized that since the matter had been discussed in the Executive Committee, it should be recorded in the minutes and implemented in letter and spirit as decided by the Council.

Members expressed differing views regarding placement and precedent and suggested that the matter be finalized by the Council. Mr. Imran Minhas appreciated the display of the pictures, stating they deserved the honor.

### **d) Felicitation to Mr. Khayyam Abbasi**

The House congratulated Mr. Khayyam Abbasi on his success as General Secretary of his area association. The President noted that he won by a margin of 95 votes out of approximately 750.


### **e) Appreciation Regarding Fateha Khwani**

The Vice President expressed gratitude for arrangements of Fateha Khwani held on April 16, 2026, for his mother.

He stated that he would bear all expenses personally and submitted a cheque accordingly. He also thanked members who offered financial support but maintained his decision as a matter of principle. The House respected his decision.

### **f) Market Upgradation**

Mr. Najeeb Ellahi Malik highlighted poor market conditions in Islamabad. The President informed the House that CDA had assured transformation of markets into model markets within four months.



He also shared updates on meetings with CDA, policy discussions on property valuation, and upcoming engagements, including hosting of the Federal Interior Minister.

He emphasized the need for an improved business climate and noted growing foreign investor interest in Pakistan.

There being no further business, the meeting concluded with a vote of thanks to the Chair.
